## Rules, Regulations, Awards, and Ticket Information

### Criteria for Tamari'i Group Otea / Aparima / Couples Solo

1. All Performers dancing, must be 16 years old and under.
2. Each Group must have a minimum of 8 dancers, no maximum.
3. Each group must perform:
  - a. Otea
  - b. Aparima
  - c. Couple Solo (one Tamahine and one Tamaroa needs to be selected to represent the group)
4. Each group must submit a fact sheet which should include: (typed not handwritten)
  - a. Group Theme (please explain)
  - b. Lyrics to the song(s) with translation
  - c. 3 copies of this fact sheet must be sent in by May 14, 2016 to
    - Ori Fest 2016, 3030 Rigel Ave, Las Vegas NV 89102
    - No Entries will be accepted after May 14, 2016
5. Time Limit: Maximum of 25 minutes
6. Penalty: 10 points deducted for going over the time limit.
7. Ticket Information:
  - a. All "Performing" dancers and musicians must purchase an entry ticket
  - b. Except, those who entered in the solo competition.
8. Awards:
  - a. 1<sup>st</sup> Place: Tari Parau, A Fa'atete, and a Trophy
  - b. 2<sup>nd</sup> Place: A Trophy
  - c. 3<sup>rd</sup> Place: A Trophy
